NOTICE OF MANDATORY PARTIAL REPAYMENT

This notice (the “Notice”) has been sent on 10 January 2024 to the Bondholders directly registered as of 9 January 2024 in the debt register (Sw. *skuldbok*) kept by the CSD. If you are an authorised nominee under the Swedish Central Securities Depositories and Financial Instruments Accounts Act (Sw. *lag (1998:1479) om värdepapperscentraler och kontoföring av finansiella instrument*) or if you otherwise are holding Bonds on behalf of someone else on a securities account, please forward this Notice to the Bondholder you represent as soon as possible.

Nordic Trustee & Agency AB (publ) acts as agent (the “**Agent**”) for the holders of the bonds (the “**Bondholders**”) in the above mentioned bond issue with ISIN SE0015807888 with an aggregated amount outstanding of EUR 55,000,000 (the “**Bonds**”) issued by Catena Media Plc (the “**Issuer**”). All capitalised terms used herein and not otherwise defined in this Notice shall have the meanings assigned to them in the terms and conditions of the Bonds as amended and restated on 10 January 2024 (the “**Terms and Conditions**”).

In its capacity as Agent, as requested by the Issuer, the Agent initiated on 19 December 2023 a procedure in writing (the “**Written Procedure**”) by sending a notice of Written Procedure to the Bondholders as required by the terms and conditions for the Bonds, whereby Bondholders can vote for or against the Issuer’s request as set out therein.

This Notice is sent by the Agent upon request from the Issuer. Pursuant to Clause 10.4 (*Mandatory partial prepayment*) of the Terms and Conditions, the Issuer shall no later than on the date falling twenty (20) Business Days after the conclusion of the Written Procedure initiated on 19 December 2023 repay fifty (50) per cent. of the outstanding Nominal Amount at a price equal to one hundred point six (100.60) per cent. of the Nominal Amount (being an aggregate amount of EUR 27,665,000) plus any accrued but unpaid interest on the repaid amount (the “**Mandatory Partial Prepayment**”).

This Notice is sent to the Bondholders in order to inform that the Issuer will carry out the Mandatory Partial Prepayment on 2 February 2024 to the Bondholders through Euroclear Sweden. The payments will be made on a *pro rata* basis to the Bondholders who are registered as a bondholder in the Company’s debt ledger held with Euroclear Sweden on the record date on 26 January 2024.
